The Reassignment of Public Guardians) PJ ORDER # 926


The Office of Public Advocacy (OPA) acts as the guardian or conservator for persons who need that protection by virtue of incapacity or minority.¹ OPA is experiencing staffing shortages such that its existing guardians/conservators may soon be assigned too many cases for them to handle responsibly. OPA has arranged to transfer 45 cases to Cache Integrity (CI), a non-profit guardianship organization. A list of the cases is attached.

In order to effectuate these transfers expeditiously, OPA may file a single motion under the present case caption to substitute CI for OPA as the public guardian in this case. The Presiding Judge will appoint a single Court Visitor to all of the cases. The Court Visitor shall communicate with the respondent in each case and determine if the respondent objects to the transfer. If a respondent objects, then the Court Visitor will advise the Presiding Judge of the objection and the Presiding Judge will appoint an attorney to represent the respondent. The Presiding Judge will hold a hearing to address the objections, if necessary.

If there is no objection to the transfer or the transfer is approved after an objection is raised, then the Presiding Judge will issue an order in each individual case documenting the transfer.
