**ORDER NO. 1837**

Adopting revisions to the venue map and community chart referenced in Criminal Rule 18.

**IT IS ORDERED:**

The revised venue map and community chart is approved by the court effective July 15, 2014. The venue map and community chart eliminate McGrath and Tanana as presumptive district court trial sites and as district court venue districts. The revised venue map will appear on the Alaska Court System website at <http://courts.alaska.gov/venuemapinfo.htm>, and the chart will be published in the Alaska Rules of Court immediately following Criminal Rule 18. A copy of the community chart is attached to this Supreme Court Order.
