Amendment No. 3-- Establishi a Magistrate Post at Whittie Further Amending Supreme Cou Order No. 253, and Authorizi the Administrative Director to Make Temporary Reclassifi cations in Magistrate Salary Levels.

IT IS ORDERED:

1. A magistrate post at Salary Level I is established at Whittier.

2. Supreme Court Order No. 253 is further amended by adding "Whittier" to the magistrate posts listed therein under Salary Level I.

3. When there is a substantial change in the caseload or level of duties at a magistrate post, the Administrative Director may authorize a temporary reclassification in the magistrate salary level for that post not to exceed one year. Permanent salary level reclassifications shall be authorized only by order of this court.
