IT IS ORDERED:

Rule 41, Rules Governing the Administration of All Courts, is amended to read:

**Rule 41. Case Numbering.**

The administrative director shall designate the procedure to be followed by all district and superior courts in numbering cases. All case[S] numbers shall include a prefix indicating the location of the court where the case is filed. The prefixes for the courts are as follows:


